Anastasia Kesidou is an Assistant Professor in Comparative and Intercultural Education at the School of Philosophy and Education, Aristotle University of Thessaloniki. A graduate of the same university in Education, Philosophy and Psychology, she holds a Doctorate (PhD) in Education from the University of Heidelberg, Germany, which she undertook under the supervision of Professor Volker Lenhart, in the framework of a scholarship awarded by the German Academic Exchange Service (DAAD).

She has worked as a research associate at the Research Unit of Comparative Education at the University of Heidelberg, as well as a consultant for UNESCO regarding peacebuilding education in post-war Bosnia and Herzegovina. Since 2000 she has been involved as a coordinator and/or researcher in various national and European projects in the areas of intercultural education and international communication, funded by the Greek Ministry of Education and the European Union.
